### **Important message**

*London, 06.09.2022*

*Dear Mrs. Hahn, dear Mr. Fried,*

against you and Mr. Adam Fried has been reimbursed by my company at the prosecutor's office in germany criminal complaint because of false, untrue oaths, official fraud, attempted murder of Ms. Stöhr, aiding, serious white-collar crime, gang crime, corporate theft and attempted flight abroad in an ongoing investigation, acceptance of benefits, bribery and serious bribery, serious personal injury, copyright and trademark infringement.

Don` t try to disguise this fact by the family Seehofer. Similarly, you have to bear the consequences of theft of studies abroad and have seriously injured an innocent woman in a wheelchair with a murder attempt. You really have very great difficulty and I strongly advise you to solve them as soon as possible, rather, than continuing to be on the run and to support the family Seehofer with aid of criminal acts.

Seek urgently medical help and a lawyer who clarifies the criminal offenses for you in the police and the district court in Germany. Surely there is also a district court in your place of residence, where you can help you through a professional medical officer or a care. Let yourself please help of a specialist who can help you out of your depravity, as well as the exercise of hypnosis, with which you have injured countless people and people like Mrs. Stöhr through third parties and engage with financial and existential damage.

Also, know that these treatments can cause irreparable damage and therefore death especially if you are not in a stable physical condition? Therefore, they are also made responsible if someone injures or dies on their treatments like Mrs. Seehofer about third. Therefore, you also have to bear the consequences for company Hypnotica GmbH in whose company you have also caused billions in damages.
