Marion stiehlt immer wieder mein Gedankengut und meine Persönlichkeitsentwicklungen und kopiert mich in Ihrem schizophrenen Verhaltensmustern nach. Marion hatte mir als ich 17 Jahre alt war meine komplette Wohnungseinrichtung gestohlen. Mein Anwalt hat den Vollstreckungstitel wegen Veruntreuung und Betrug nach 10 Jahren nochmal verlängert. Der Vollstreckungstitel ist noch rechtsgültig um mein Geld was mir durch meinen Anwalt und gerichtlich zugesprochen wurde von Monique und Marion zurückzuholen, worin Monique nach Amerika flüchtete.

Sicherlich hat mich Marion im Internet wieder abkoppelt und gestohlen indem sie sich an meinen Webseiten, Kunstart und Texten bereichert und mich anschließend aus dem Weg räumt, damit Papa und Mutti isoliert werden in Lügen und alten vergangenen unwahren Geschichten fest-hängen die längst Vergangenheit sind.

Deshalb glaube ich das nur Schadenersatzansprüche und eine straf. Unterlassungs- und Verpflichtungserklärung diese Intrigen, Falschheit und Lügen öffentlich auflösen können. Marion versucht zu verhindern, dass ihr meine Webseiten und Blogs lesen könnt, weil sie Mutti lügen erzählt ich hätte mein Geld für was anderes ausgegeben. Natürlich dürft ihr auch nicht erfahren, dass ich seit 10 Jahren eine bekannte Vorreiterin und Künstlerin in Deutschland geworden bin.

Papa, wenn Du mich bis Sonntag nicht anrufst schicken Manuel und ich die Polizei vorbei und ich erstatte endlich die Strafanzeige die ich vor 20 Jahren hätte sollen schon gegen Marion stellen.

Gibt beide daher Marion keine Unterschriften und unterschreibt nichts. Sie machen das selbe Spiel mit Euch wie damals mit mir und isolieren Euch. Ihr kennt Monique wie sie ist. Sie lacht über Euch und hat immer schlecht über Euch geredet und über Euch gelacht. Marion kommt nicht mehr raus weil Monique sie im Griff hat, weil sie alle Jahre mitgemacht hat, mich und Babys als Babysitterin von der US Air Force Spangdahlem zu foltern und zu quälen. Sie hat mir sogar die Eisen-stange von meinem Rollstuhl auf den Kopf geschlagen und mich dann mit Loch im Kopf an den Haaren ins dunkle Schlafzimmer auf mein 1 Meter 50 hohe Bett gezogen.

Donald fand mich morgens mit ein Loch im Kopf in letzter Minute auf meinen verblutetem Bett. Sie schlug auch Angela jede Woche im Auftrag von Monique und warf das kleine Kind von Ecke zu Ecke an den Armen durchs Zimmer in ihrem Suff. Das machten beide auch mit mir und die Kinder der US Air Force Spangdahlem die wurden bis zu 8 Stunden auf ein Plastiktopf gesetzt bis der Hintern knallrot war und bevor die Eltern kamen wurden sie dann runtergeholt schreitend vor Schmerzen.

Die Kinder mussten auch 8 Stunden in einer Ecke stehend mit Händen auf dem Rücken, die Be-schimpfungen von Marion und Monique ertragen ohne sich zwischendurch mal hinsetzen zu dürfen. Ich für meinen Anteil bin im Rahmen meines Anschreibens mit Euch beiden Elternteilen in die Wahrheit und Klärung gegangen und lege auch diesen Lebensabschnitt für mich ab mit reinem Gewissen und reinem Herzen.

Liebe Mutti ,ich wünsche Dir, dass Du frei kommst aus diesem Lügengeflecht und diese grausamem Straftaten nicht mehr länger mit decken und verschleiern musst, als Mittel zum Zweck zu einer Mittäterin gemacht worden zu sein.

Aus diesem Grunde überlasse ich Dich Deinem Schicksal, welches Du für Dich selbst gewählt hast und nun mit der Wahrheit und Aufklärung innerlich vielleicht irgendwann einmal gesund werden kannst aus Deiner Erkrankung von Marion.
