### Written warning according to international trademark law

Dear managing director Mrs. Angela Merkel,  
dear succeeding managing director Mr. Olaf Scholz,

due to the multiple warnings as managing director (DUNS® number: 31-497-2740) according to §19 MarkenG of December 21th, 2019 on January 20th, 2021, as well as the one to you in writing on April 11th, 2021 as an order in Art of Lordin Maya the following additional contractual claims for damages were ignored and not complied with.

The trademark services provided to Sabrina Seehofer were terminated in writing in 2016, but no termination agreement has been concluded to date.
