in the context of the highly criminal electoral fraud and the world's largest corporate and student theft to date, as well as the largest business and gang crime of all time, I file criminal charges at all Air Force stations, as well as in the Pentagon. 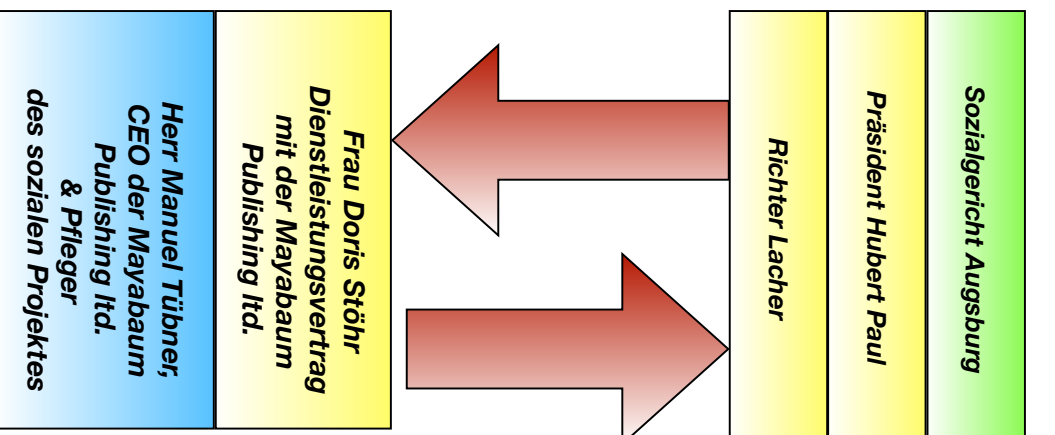
Trotz nicht bezahlter Versicherungsbeiträge der Rechtsschutz durch die unberechtigten Geldkürzungen hat Frau Stöhr eine Deckungskarte von Ihrer Versicherung erhalten, was eine absolute Ausnahme war.

Rechtsanwältin Frau Bobinger hat sich trotz Vorwarnung das jeglicher Kontakt mit dem Landratsamt Oberallgäu mit Vorsicht zu genießen ist, unerlaubt Kontakt hergestellt. Sie ist schließlich auf einen Betrug den Ihr von Landratsamt Oberallgäu glaubhaft gemacht wurde reingefallen und Frau Stöhr hatte seitdem keine Rechtsanwältin mehr, da man eine Deckungskarte der Versicherung nur einmal verwenden kann.

Nachdem alle Betreuungsanträge, Strafanzeigen aufgehoben wurde haben Frau Stöhr und Herr Tübner sich selber an das Sozialgericht Augsburg gewendet.



Doch anstatt den kompletten vorliegenden Order von dem gesamten Zeitraum zu studieren, um endlich für Klarheit zu sorgen, wurde ein geringer Anteil des Beschlusses wahrgenommen, da sich das Sozialgericht ohne Prüfung des Sachverhaltes die fertigen Textbausteine des Landratsamtes Oberallgäu übernommen hat und sich somit den Sozialbetrug, Markenverletzungen und Vertragsverletzungen angeschlossen.

Mit dem Gerichtsbeschluss hat Herr Zeller jedoch Frau Stöhr nach zwei Wochen immer noch nicht ausbezahlt und es wurde ein einstellige Verfügung an das Amtsgericht Sonthofen ausgestellt. Selbst das hat das Landratsamt Oberallgäu jedoch missachtet und hat nur Frau Stöhr eine Anteil ausbezahlt, obwohl ihr die die 520 € laut Beschluss des Sozialgerichtes Augsburg zustehen. Daher wurde ein Haftbefehl wegen Missachtung des gerichtlichen Beschlusses des Sozialgericht Augsburg an das Amtsgericht Sonthofen ausgestellt gegen das Landratsamt Oberallgäu. Doch weder auf die einstellige Verfügung noch der Antrag des Haftbefehl wurde beachtet und blieb bis heute unbeantwortet. Verfahrensfehler !

1. General facts of the criminal complaint

The persons listed above are responsible for all of the criminal offenses listed.

Sequence of events, 1991-2020

In 1991 I suffered paraplegia due to a car accident. My attorney at the time, Christoph Mrziglod & colleagues Lawyers, Kirchplatz 2, 66571 Eppelborn, had made it possible for me to receive a one-off severance payment of 870,000 German marks from the insurance company, with which I could have built a healthy and good future until today.

My aunt Monique Humphrey is married to the Air Force officer, Donald Humphrey, who was stationed in Korea and Holland for many years and then lived at Spangdahlem Air Base and in Beilingen, Auf der Kehr 5. Monique and Donald Humphrey looked after babies from families at Spangdahlem Air Base and all other Air Force stations before and after from 1991-1994 because they had financial problems and Monique Humphrey is predisposed to torturing babies and children with her strict parenting methods. The babies and children were abused by Monique and Donald Humphrey.

The babies and children were tortured for 6 to 7 hours by sitting in baby toilets on sharp plastic for hours and were put in the corner for hours with their heads facing the wall and hands behind their backs, as well as being pulled out of the beds by their arms and with the head banged on the floor while changing diapers. The children and babies cried out in the pain and agony inflicted upon them. Monique and Donald Humphrey also exposed me to abuse as a disabled person in a wheelchair. If I wanted to help the babies, I was also discriminated against and tortured in a wheelchair.

They isolated me from the outside world for many years and locked me up in their house for a long time in order to embezzle my one-off settlement of 870,000 German DM. Monique and Donald Humphrey used my money to book a trip to North Carolina and used my money to buy new cars, jewelry, furniture, dogs every day and to use my money to rebuild their old house.

My lawyer bought me a car so that I could be mobile because of my disability. My lawyer wanted to put my one-off severance payment of 870,000 DM in the bank for 10 years so that I could live on monthly interest of 6,000 DM for 10 years and ten years later I would have all of my money at my disposal again from the bank and could have re-invested it as capital. Monique and Donald Humphrey always wanted money from my lawyer before this payout, even though there was none.

My sister Marion Garcia joined forces with Monique and Donald Humphrey and embezzled my money with Monique, Donald and their children Pascal Kessler-Humphrey and Nicole McKenzie. My sister Marion even took my car away from me, which I had bought with my money from my lawyer for my disability and which was basically needed to be mobile. My sister also supported my aunt Monique in torturing and abusing me and the babies of the parents from AirBase Spangdahlem.

I was even pulled out of the wheelchair by my sister and Monique Humphrey onto the floor and then hit my head with the footrest, the iron bar, so that I suffered a severe head injury and bleeding. The reason for this attack was because I didn't want to give my sister and Monique Humphrey any more money to build a future with my money.

In 2015 I and my former lawyer are also looking for the notary where my aunt Monique and Donald Humphrey will have all of my money notarized when I die. They forged my signature because I have never seen this notary in person, let alone seen or know him personally. Unfortunately, my lawyer Christoph Mrziglod has not been able to locate the notary to this day in order to resolve the fraud of embezzlement, forgery, and stealth, as Monique and Donald Humphrey still have this notarial deception with a forged signature and withhold the name of the notary from me.

When I die, Monique, Pascal, Nicole and Donald Humphrey get all of my inheritance and everything I own. In the meantime I was able to submit a counter-document to a notary, which Monique, Pascal, Nicole and Donald Humphrey and Marion Garcia do not know. I wrote to Donald Humphrey on Facebook on March 27, 2020 and informed him by voice message that he should please inform President Donald Trump and the army that all my company concepts and pioneering studies had been stolen from me in Germany by the Markus Söder clan, wherein world domination is planned to eliminate all humanity.

Donald Humphrey saw this as an opportunity to get a lot of money again and kill me. Donald Humphrey blocked me on Facebook and got involved in the corruption Landratsamt Oberallgäu/Alfred Seehofer Humphrey family, paired in the clan Prime Minister Markus Söder. My attorney was able to obtain a repayment against Monique and Donald Humphrey in 1991 under an enforcement order, but they fled to Georgia in the middle of the enforcement process and fled with my money. In 2018 I contacted Spangdahlem Air Base and got help and support from a policeman named Thorsten Damm, mobile: 0176 84729537.

Pascal Kessler-Humphrey and Nicole McKenzie took part in the abuse against me as a paraplegic and the children and babies of the parents of the army and also carried it out to this day, as well as embezzling my money. Monique and Donald Humphrey have joined the Oberallgäu/Fam.Seehofer, the clan Prime Minister Markus Söder and have accepted bribes to influence the election of President Donald Trump with fraud and to deal with corruption and the Söder clan kill.

When I die my pioneering role belongs to Monique Humphrey, the corruption clan Söder and presidential candidate Joe Biden, who made contractual agreements with the Söder clan, the entire German federal government, the European Commission of Brussels, the WHO and the pharmaceutical industry, Bill Gates etc. has met. These will come into effect in full on January 20th, when Joe Biden is sworn in as President of the United States. The planned RESET of mankind is also planned, which began with the planned Covid19 pandemic through the global economic collapse, the destruction of the banking world through a financial collapse, mass murders through vaccinations, targeted impoverishment of mankind with associated famines, civil wars, etc. - and that's just the beginning of what to expect.

Credibility

The enforcement title for Monique and Donald Humphrey, which was extended to the next 10 years, is, with other previous documents and legal documents, with lawyer Christoph Mrziglod & colleagues Lawyers, Kirchplatz 2, 66571 Eppelborn. This is where the entire facts of the past 30 years are located. The Monique Humphrey file is in the archive as an extraordinary special case of a serious crime against me and against many poor, affected babies and toddlers in the US Army.

Note on the origin of corruption :

We are both managing directors of Mayabaum Verlag-Zukunftsbasis® Ltd. And have multisensory skills and a higher level of intelligence. In 2016, as part of a company restructuring of company Perilia Human Resources GmbH, the Alfred Seehofer family stole all of our company's know-how and our pioneering studies, in which our EU brands and contracts were deliberately violated and our entire company structure in Art of Lordin Maya was stolen.

In conjunction with our service contract for company restructuring in 2016, no cancellation agreement has been concluded with us to date and the entire know-how of Mayabaum Verlag - Zukunftsbasis @ Ltd. has been stolen from the Seehofer family with our globally unique company concepts and pioneering studies, the Seehofer family built up illegally and handed over our company concepts to the Oberallgäu District Office and, with the political federal party CDU/CSU of Bavarian Prime Minister Markus Söder, corruption throughout Germany with over 8 murder attempts on us exercised. The white-collar crime was then spread in the Munich celebrity scene and everyone joined in violating our EU trademark rights and contractual rights. The evidence that we have been able to collect to date is over 200 GB and 200 files of evidence.

The whole of Germany was involved in this crime by the Söder clan and spread to the art of Lordin Maya, as well as the whole of Germany embodied in Art of Lordin Maya. Prime Minister Markus Söder had also stolen all of our company and trademark contracts, as well as the preamble and the entire company structure, which were submitted to the State Ministry of Munich to inspect the files of the criminal charges at the responsible public prosecutor's offices and were then embezzled there.

In 2016, Tanja, Sabrina and Alfred Seehofer gave me an injunction at the Kempten Regional Court with our English company. Our English company was simply written to my former German private address, which was protected by the author, and was driven to ruin with staged enforcements, although our company does not have a representative in Germany and is not registered in the commercial register, but has been registered in Companies House in London since 2015 according to Common Law and sovereignty in Art of Lordin Maya. These fraud files have been sabotaged for years to this day in order to disguise that our company is registered in England and that all letters sent to German addresses so far were a fraud.

Clan Söder aims to have our English company contracts invalidated since December 2016 so that my contractual rights are not recognized. Clan Söder is carrying out this criminal act in order to steal my pioneering studies and company know-how, to continue to operate the frauds and, on the other hand, not to pay the claims for damages under trademark law for five years, and not to have to sign the cancellation agreement from December 2016. Because the termination agreement would be an admission of guilt which must be prevented with all arbitrary violence from the whole corruption, as well as preventing my study material from returning to my property under trademark law.

However, the termination agreement was prevented by deliberately sabotaging all of our criminal charges.
