Letter to the United Nations of America

Dear Office of the AF Inspector General, Dear Major General Randall Reed,

Given the current situation, it is impossible to hand over 6 years of corruption on the basis of evidence in a few hours, to have a legal review with a pending court judgment. Just sending finished evidence with emails would take a few days, so extensive is the gang and white-collar crime that we have collected in detail and can clarify it informatively and purposefully in front of a court.
