We, Mr. Manuel Tuebner and Ms. Doris Stoehr, directors of Mayabaum Verlag-Zukunftsbasis® Ltd., hereby file a criminal complaint against the following persons

1. General facts of the criminal complaint

The persons listed above are responsible for all of the criminal offenses listed.

Sequence of events, 2016-2020

Julia Fried (born Hahn) took advantage of contractual advice in Art of Lordin Maya in July 2016 as part of the service provided by Mayabaum Verlag - Zukunftsbasis Ltd. At that time, Julia Fried was single, dissatisfied with her professional life as a teacher and lived as a roommate in a shared apartment with Sabrina Seehofer, Rablstrasse 31, 82699 Munich.

In the service contract, it is forbidden to pass on know-how during the consultations and not to pass on confidentiality and services to other service providers due to trademark rights. Julia Fried committed this breach of contract intentionally and completed the hypnosis training at the Hypnosis Center in Munich without terminating my contract.

Julia Fried then joined Sabrina Seehofer and submitted untrue facts about the affidavit for the Kempten District Court. Despite the clear evidence, the injunction was not rescinded with intentional false address information. Since then, every police station, public prosecutor's office and all courts in Germany have joined me, Manuel Tuebner, privately with the company address and the London company address at Doris Stoehr's place of work.

Judge Lechner from the Kempten Regional Court neither checked the facts for accuracy nor accepted the clear evidence to dismiss the lawsuit. When we became aware of further breaches of contract and trademark infringements in the following months, together with other people who had joined Sabrina Seehofer, Tanja Seehofer and Julia Fried, the facts were again summarized and submitted to the Munich police. Unfortunately, we were rejected with our facts and should report to the public prosecutor in Munich, which we then implemented. There, too, we were rejected with our criminal complaint for irrelevant reasons, although the white-collar crime with our stolen company know-how had suddenly joined forces with over 24 people. Even if the current evidence may not seem 100% sufficient, at least a review should have taken place at this point. After all, the germ of a serious rampant gang crime was already recognizable here with all the criminal energy to be able to prevent even worse.

In 2017, after researching the Internet, Julia Fried fled to the USA with the help and support of lawyer Anett Raumschüssel and colleagues. In addition, Sabrina Seehofer, who was also under a service contract, but also violated it, Julia Fried with our company know-how coached her then relationship partner Adam Fried entrepreneurially with our trademark rights, so that Adam Fried then married Julia Hahn.

After further research, Sabrina Seehofer allowed Julia Fried to visit the USA in November 2017. One can assume that due to the long-term economic and gang crime with the extensive criminal offenses of the last few years, further front companies with accounts in the USA have been built up for the purpose of embezzlement and money laundering. It cannot be ruled out that, due to the close links with the corruption of Germany, the fraud of the US presidential election was planned and implemented for a long time and in a perfectionist manner.

Finally, planned procedures point to corruption in Germany, where the election fraud server was discovered. On the one hand, in our case in Germany, an address scenario was implemented in the wrong legal framework. During the US elections, addresses on ballot papers were also invented or even filled out by the dead. And last but not least, the connections are also there, such as Sabrina Seehofer and Julia Fried.

Another contact was established from the USA via Germany via the person Greville Henwood GroovyKids™ Yoga, who was also given my company concepts and company know-how which they stole in my company via Julia Fried and Adam Fried.

How far white-collar crime has spread in the USA since 2017 needs to be re-examined. But due to the prevailing presidential fraud election in 2020, one can assume a great deal of criminal energy, which must be stopped immediately.
