Powers of attorney are in duplicate, handwritten, and digitally linked to the service contract from December 2019, notarized and issued with a notarial deed and an international notarial certificate. Originals by Ms. Bucher are handwritten and are available to my company Mayabaum Verlag- Zukunftsbasis® Ltd. Certified by a notary, they are subject to international legal validity.

Documents certified by a notary public were submitted and the precautionary mandate deposited with the civil registry office in Switzerland.

Dear clinic Holtby Ward Elgar Unit, dear Dr. Word,

as a general power of attorney, you are obliged to maintain contact with our client Ms. Antoinette Bucher.

As a patient informed us on Facebook, you put Ms. Bucher on drugs containing LSD, locked her up and isolated her. A patient told us on Facebook that Ms. Bucher had attacks of faintness and headaches because of the overdose of the medication she was given. Nevertheless, you forced the drug to be taken against the wishes of our client Ms. Bucher.

We would like to point out that we, as the authorized representative, make decisions about Ms. Bucher and that you have made yourself liable to prosecution for this reason. You broke off contact with our client, locked her up and isolated Ms. Bucher from us. You also put Ms. Bucher on medication without our consent and prevented her from looking for a planned job.

We set you a deadline of February 17, 2021 to re-establish contact between our client Ms. Bucher and us. According to a patient on Facebook, you had Ms. Bucher isolated under control until February 17, 2021, put under LSD and tons of medication without permission, and forcibly detained.

We had also presented and handed over to Rebecca Lane our power of attorney and notarial internationally legally valid document.

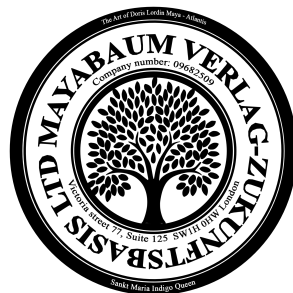
