Subject: Formal Complaint by Doris Stoehr and Criminal Allegation on behalf of Elon Musk

Offenses Alleged:

Physical abuse, injury, and exploitation of a person with autism (Elon Musk), financial harm, contractual abuse, public relations (PR) fraud, embezzlement of funds, white-collar crime, organized/clan crime, and extortion in connection with contracts and Non-Disclosure Agreements (NDAs) that Elon Musk was forced to sign under duress, coercion, and deception by Melania Trump.

Statement of Facts and Legal Grounds

1. Procedural Unconscionability

The formation of the contracts in question was fundamentally flawed, relying on coercive power, extortion, and an extreme power imbalance driven by Donald and Melania Trump's corporate influence. Elon Musk was targeted through surprise tactics, deliberate deception and unfair clauses hidden in the fine print, rendering these agreements exploitative contracts of adhesion.

2. Substantive Unconscionability

The terms of these agreements are unconscionable, coercive, and extortionate. They force Elon Musk to subject his autism to public relations fraud involving escort individuals forced upon him as a "gift" by Melania Trump under the terms of the NDA. These conditions strip Elon Musk of his right to a free life and autonomous decision-making. He operates under severe duress, including threats to his life by Melania Trump. Under these terms, he is prohibited from speaking freely to anyone, publishing information, or maintaining a free and open relationship with Doris Stoehr. He is banned from publicly mentioning Doris Stoehr or providing her with financial support, forcing him to keep his contact with the woman he loves strictly hidden.

3. Invalidity and Illegality of the NDA (Public Policy and Overbreadth)

- **Overbreadth:** The NDA imposes an excessive, lifelong ban on the signatory, preventing Elon Musk from speaking about his general professional experiences or industry knowledge.
- **Violation of Public Policy (Reporting of Crimes):** The NDA imposed by Melania Trump purports to contractually forbid Elon Musk from reporting crimes and criminal activities to law enforcement.
- **Whistleblowing Restrictions:** The agreement unlawfully obstructs cooperation with government authorities, using extortion to prevent whistleblowing and violating established public policy and order.

Narrative and Background

This complaint is submitted due to targeted physical, psychological, and financial harm inflicted upon Elon Musk and myself, alongside the intentional interference with our romantic relationship and partnership.

It is alleged that Melania Trump pressured Elon Musk under duress and deception into signing this Non-Disclosure Agreement. Furthermore, it is alleged that Melania Trump utilizes identical coercive NDA tactics against Donald Trump with the intent to unlawfully acquire the total assets of both Donald Trump and Elon Musk, severely endangering their health and lives.

The accused are charged with systematically exploiting Elon Musk's autism for PR fraud and financial enrichment. This exploitation specifically targets the symptoms and characteristics of his condition, including physical boundaries regarding intimacy, dancing, and physical touch, as well as the occurrence of autistic twitches and tics. Through an agreement into which he was lured via deception and extortion, he is forced to appear publicly with paid escorts to present a fraudulent image of a traditional family to society.

Furthermore, Dan Scavino and his partner Erin Elmore are accused of deliberately orchestrating severe physical and psychological harm against Elon Musk to embezzle substantial sums of money through this PR fraud and to secure unauthorized political and financial advantages.

Conclusion and Request for Action

I hereby urge the United States Department of Justice to initiate a comprehensive investigation into these matters and to review the legality and validity of the contracts and NDAs executed under duress.

Please contact Elon Musk directly regarding the legal proceedings he has initiated in connection with the contracts and NDAs between himself and Melania Trump, which were signed under coercion, deception, and extortion, and which severely threaten Elon Musk's life and well-being under coercive force.
